On motion of Mr. McCellan seconded by Mr. Haley the Reeve was authorized to interview Mr. Robt. Ritchie with a view to purchasing from him a road way round rock on 7<sup>th</sup> Concession opposite the N 1/2 of Lot No. 3.

On motion of Mr. Inelung seconded by Mr. Healy the Reeve was authorized to have the Ditches and Water Course Act put into operation if necessary with reference to the drainage of Concession 5<sup>th</sup>

Foresters Hall Dec 1<sup>st</sup> 1906

The regular Meeting of Council was held here this day at 10 o'clock A. M. all the members being present, the Reeve in the Chair.
