

2 Foresters Falls Nov 4 / 22

The regular monthly meeting of the Municipal Council of the Township of Ross was held here on the above date. All members of Council were present, the Reeve in the Chair. Minutes of last regular meeting were read, approved and signed by the Reeve. Communications were then read and considered. Meeting then adjourned to meet again in one hour.

On reassembling Mr. A. Rathwell gave notice that he would at this meeting of Council introduce a bylaw to authorize and provide for the improvement of certain main and leading roads in the Township in the year 1923 under the terms and conditions of the Colonization's Roads Act.

Mr. Rathwell then introduced bylaw no 397 of which he had given notice, and on his motion seconded by J. H. Barr the bylaw was read a first time.

collector for the current year at a salary of \$100.00.
