

Foresters Falls Dec 15<sup>th</sup> 1924

A Regular Meeting of the Municipal Council of the Township of Ross was held according to Statute in the Hall here on the above date with a full Council present. Minutes of the last Regular Meeting and of a subsequent Meeting were read approved and signed. Mr Nelson Bell appeared before Council asking a grant to the Foresters Falls Library Council promised consideration. A number of Communications bills and accounts were then read and considered Council adjourned for one hour. On reassembling Mr. Wallace gave notice that he would at this meeting of Council introduce a Bylaw to make provision for holding the ensuing Municipal Elections.

Councillor Mosam gave notice that he would at this meeting of Council introduce a bylaw to authorize and provide for the Construction and improvement of certain main and leading roads in the Township in the year 1925 under the terms and conditions of the Colonization Roads Act Moved by D. McDonald sec by John Wilson that a vote of approval and appreciation be passed by Council in favor of the Trust Officer motion carried unanimously

Mr. Wallace then introduced Bylaw No 414 of which he had given notice and on his motion seconded by D. McDonald it was read a first time.
