A Regular Meeting of Ross Municipal Council was held in the Hall here on above date
 Present Councillors Wallace Moxam Wilson & Reeve Jamieson
 The Minutes of last Regular Meeting were read approved and signed by the Reeve
 Communications Bills and accounts were read and considered
 Council adjourned for one hour On reassembling
 Mr. H. Guest was present soliciting a Grant to Cobden Fall Fair on motion of A Wallace see by J Moxam Council made a grant of \$50⁰⁰ to Cobden Fair
 Messrs Duncan Headrick and Allan Oates appeared asking Council to secure under the provisions of the Tile Drainage Act a loan of Two Thousands Dollars each from the Provincial Government
 The Clerk was instructed to give the necessary advertising notice of a By-law to be passed on Oct 6th to authorize the borrowing of up to \$200,000 for ^{tile} drainage purposes under the provisions of the Tile Drainage Act
 Mr. Moxam gave notice that he would at this Meeting of Council introduce a By-law to authorize and provide for the levying of all necessary rates for the present year
 Mr. Moxam then introduced By-law No (444) and on his motion see by J. Wilson it was read a first time
