The Municipal Council of the Township of Ross met on the above date at 10 A.M. All members present.

Minutes of last meeting were read, found correct and signed by the Reeve.

Communications and accounts were read and considered.

Mr. Ed. Gibson came before Council re the buying of G. Y. Couster Estate. Council left the matter over until Aug. meeting. Mr. Gibson in the meantime to try and find a buyer for part of the property.

Messrs. M. Gibson and Alex Jamieson interviewed Council in connection with $W\frac{1}{2}$ Lot 26, Con. 6, now owned by Township. It was decided not to do anything definite with this property until the next meeting and the Clerk was instructed to advertise same for sale in the Kennew Mercury.

Arnold + Archie Catter appeared before Council regarding Tile Drain Loan. Mr. Tom. Stephens appeared before Council asking for rebate on interest and Penalties on his arrears, also stating there was a mistake in his arrears, as the Treasurer was at the meeting, Mr. Stephens was referred to him.

Mr. Jeffery gave notice of a By Law for the purpose of setting a special rate to be levied on Lots 8 $\frac{1}{2}$, 15, 16 Con 6 + 7, also on $W\frac{1}{2}$ Lot 11 Con. 6, under the Tile Drainage Act.

Mr. Jeffery then introduced By Law No. 525 of which he had given notice and on his motion seconded by Mr. Dutton was read a first time.
