Saturday Oct 1/38

The Municipal Council of the Township of Ross met on the above date at 10. A. M. All members present.

Minutes of last meeting, were read, approved of and signed by the Reeve.

Communications and accounts were read and considered.

Mr. Dretton gave notice of a By-law to repeal By-law no. 525.

Mr. Fraser gave notice of a By-law to set a special drainage rate on Lots 15, & 16 Con 6 & 7.

Mr. Jeffrey gave notice of a By-law to set a special drainage rate on $7\frac{1}{2}$ Lot Con 6.

It was moved by James Bruce seconded by R. A. Fraser, that D. J. Mc Laren be appointed Tax Collector for the Township for 1938, at the usual salary carried.

Messrs Ed. Pettigrew and Robt. Bennett, intervened Council re Award Lett.

The Clerk was instructed to write Alan McCulloch, and James Wright in connection with cleaning out of their share of Award Lett.

The Reeve was appointed to see Chown + Chown Rempew, regarding John A. Wilson.

Mr. Dretton then introduced By-law no. 527, a By-law for the purpose of repealing By-law no. 525, and on his motion, seconded by Mr. Fraser was read a first time.

On motion of Mr. Jeffrey, seconded by Mr. Fraser By-law no. 527 was ~~read a second and third time~~ read a second and third time short and finally passed (Carried)

Mr. Fraser then introduced By-Law no. 528. a By Law to set a special drainage rate on Lots $\frac{1}{2}$ 15 + 16. Con 6 + 7. and on his motion seconded by Mr. Dretton was read a first time.

On motion of Mr. Bruce, seconded by Mr. Jeffrey. By Law no 528 was filled in with the amount of \$47⁷² to be levied for 20 years, and read a second and third time short and finally passed (Carried).

Mr. Jeffrey then introduced By Law no. 529. a By Law to set a special drainage rate on $\frac{1}{2}$ Lot 11 Con 6, and on his motion, seconded by Mr. Fraser was read a first time, on motion of Mr. Bruce, seconded by Mr. Dretton By Law no 529, was filled in with the amount of \$44¹⁶ to be levied for 20 years, and read a second and third time, and passed. (Carried)
