

Foresters Falls, Ont. June 4th 1956.

The Municipal Council of the Township of Ross met on above date with Reeve J. Stewart Chiddhose and Councillors, R. Cattie and Geo. Olmstead present.

Minutes of former meeting were read and adopted. Communications & accounts were read and considered.

It was moved by Geo. Olmstead, seconded by R. Cattie that Council appoint a committee composed of R. Cattie, Wm. Stone & Geo. Olmstead to endeavour to purchase, if possible, a new site for Township dump to replace present dump at Foresters Falls.

Moved by R. Cattie, seconded by Geo. Olmstead that we pass a by-law for the purpose of appointing a Fire chief and firemen and also a schedule of wages for same to operate Township Fire Truck ~~as follows~~, wages to apply for time spent on same for any possible fire or other legitimate time required as approved by Council is as follows:-

~~The~~ Fire Chief - Roy Dittthurner, Firemen: Henry Dittthurner, Carl Pettigrew, Casey Coleman & Raymond Bell. Wages of Fire Chief \$750.00 per year flat rate to be applied to the duty of keeping Fire engine in running order draining hose and other duties required for same plus \$1.50 per hour while on call or duty at fires etc. ^{approved by Council.} Firemen's wages \$1.50 per hour while on call or duty at fires etc. approved by Council.

Moved by Geo. Olmstead, seconded by R. Cattie that Council discontinue relief to Mr. Clifford McKiddie until ^{notice} further.

Moved by Geo. Olmstead, seconded by R. Cattie that we accept & pay Road Voucher No. 5 for the month of May for the amount of \$1,647.03.
