The regular Monthly meeting of the Municipal Council of the Township of Ross met on above date with all members present

It was moved by Geo. Olmstead, seconded by Wm. Stone that we give third reading to the by-law concerning agreement between Consumers Gas Co. of Toronto and the Township of Ross authorizing the Consumers Gas Co. to construct an oil pipe line through the Township.

Moved by H. Pilgrim, seconded by Geo. Olmstead that we set the date of the Court of Revision for the purpose of hearing assessment appeals, if any, for the date of November 25<sup>th</sup> 1957 at 10 A.M. in the Fire Hall Council Chambers at Forsters Falls.

Moved by R. Oatley, seconded by H. Pilgrim that we accept resolution of School Area No. 2 authorizing that area to deposit the amount of \$2,500.00 into a Reserve Fund, if necessary, for the purpose of Capital expenditures.

Moved by Geo. Olmstead, seconded by Wm. Stone that Council give the sum of \$10.00 to the Colden and District Legion to purchase a wreath to be placed at the Cenotaph on November 11<sup>th</sup>.
