Ross Municipal Council met on above date with all members present.

The minutes of the last two meetings were read and adopted.

Moved by Alden May, seconded Geo. Olmstead that council pay the membership fee in the amount of \$30.00 to the Upper Ottawa Valley Travel Council for 1965.

Moved by Wm. Stone, seconded by R. Catter that council authorize the Clerk to pay a grant of \$45.00 to Forsters Falls Public Library for 1964 and Forsters Falls L. O. #552 for use of the hall for the year 1964 of an amount of \$75.00.

Moved by Wm. Stone, seconded by Geo. Olmstead that council pay an increase of \$100.00 per year to Mrs. Allan Cole for clerical assistance making a total of \$250.00.

Moved by R. Catter, seconded by Wm. Stone that council increase the Collectors salary from \$150.00 to \$200.00 per year and the Clerk - Treasurer salary from \$2000.00 to \$2500.00 per year.

Moved by Alden May, seconded by Geo. Olmstead that council pay the Reeve \$1000.00 per year plus expenses and the councillors \$500 per year plus expenses.
