

Forsters Falls, Ont. July 7th 1965

Rose Municipal Council met on above date with Reeve Stewart Chidderhose and Councillors Wm. Stone, George Olmstead and Alden May.

The minutes of former meetings were read and adopted.

A delegation of ratepayers of the township appeared before council to protest against the building of the new proposed Composite High School as they felt the cost of the project would be prohibitive at least at the present time.

In view of the above protest the council considered it would not be in order to appoint a Trustee to represent the Township unless or until something ^{more} definite and satisfactory has been settled upon.

It was moved by Geo. Olmstead and seconded by Alden May that council accept and pay Road Voucher No 6 for the Month of June in the amount of \$8,372.09.
