Foresters Falls, Ont. June 4th 1969

The regular monthly meeting of Ross Municipal Council was held on above date with the Reeve and Councillors H. Pilgrim, Clarence Bilson and Leo Rathwell present.

The minutes of last meeting were read and adopted by Council.

It was moved by Clarence Bilson, seconded by H. Pilgrim that Council accept the Fire Protection agreement, dated May 9th 1969 between the Village of Cobden & the Township of Ross as follows:-

The Village of Cobden agrees to provide fire protection to that part of the Township of Ross, west of Muskrat Lake north of Cobden and east of Cobden as far as the junction of Highway 17 and County Road 21 on the following terms:- Fire engine \$35.00 per hr., Firemen \$3.50 per hr.

Also, Ross Township's Fire Department is permitted to use hydrants when necessary, or to refill tanks when attending a fire in the vicinity of Cobden Village.

All calls answered by the Cobden Firemen from Ross Township are to be relayed to Ross Township Fire Department.
