

Forsters Falls, Ont. September 21st 1971

A special meeting of Council was called on above ^{date} to consider a by-law in regard to the amended Drainage Act 1971 and also to consider the matter of giving an option to lease the Township owned property formerly known as S.S. No. 1. School to Renfrew County Enterprises, Ltd.

Moved by H. Pilgrim, seconded by George Olmstead that Council pass a by-law not to exceed \$200,000.00 borrowing power under the Tile Drainage Act 1971 for the purpose of the construction of drainage works in the Municipal Corporation of the Township of Ross

Moved by Clarence Bilson, seconded by Leo Rathwell that Council agree to give an ^{option} to lease the Township-owned property and building formerly known as S.S. No. 1. Ross, part of lot 7, concession 3 to Renfrew County Enterprises, Ltd. for a period of six months for a fee of \$1.00. Council also agrees to give an option to Renfrew County Enterprises, Ltd. to buy this property within this six month period and Council agrees to transfer ownership of said property to said Company provided said Company pays all costs of transfer and survey, if needed, in the transaction.

Meeting was then adjourned.

Forsters Falls, Ont. September 23rd 1971

A special meeting of Council was held on this date for the purpose of discussing an agreement with Cobden over the use of their dump, discussing the proposed mill rate for 1971 taxes, authorizing the calling of tenders for proposed drainage at Forsters Falls, giving third reading to Forsters Falls Drainage Project and the closing of the Court of Revision Re: Forsters Falls Drainage.

Moved by Clarence Bilson, seconded by Leo Rathwell that Council accept the proposed mill rates for taxation in 1971 as prepared by the Department of Municipal Affairs as follows: Public School, Res. 17.71 Comm 19.68; High School Res. 18.73, Comm 20.81, General Rate, Res. 19.76, Comm 25.52 County Rate, Res. 18.40, Comm 18.40. Street lights 3.5 mills, Federation of Agriculture .02 mills.

September 27th 1971 Minutes (Continued)

Moved by Clarence Bilson, seconded by Leo Pathwell, that Council agree to pay the Village of Cobden their requested fee of \$200.00 for the use of the Cobden Dump for the year 1971 and, as we have been notified that we must go to land fill by May, 1972 we would agree to pay at the same rate for the number of months in 1972 that we would make use of your dump. Any grading or snowplowing that you would request from us for your dump would be charged at our going rate for these machines and also all main roads in the Township are to be plowed before any lanes or roads such as these are snow-plowed.

A Court of Revision was held to consider any appeals received in connection with the Foresters Falls Drainage Project. One appeal was heard and dealt with and it was moved by H. Pelquin, seconded by George Olmstead that Council now close the Court of Revision.

Moved by Clarence Bilson, seconded by Leo Pathwell that Council give third and final reading to By-law No. 983A in regard to the Dile Drainage at Foresters Falls.

Moved by George Olmstead, seconded by H. Pelquin that Council authorize the firm of Green, Salloway & Associates, Ltd. to call tenders for the construction of the Foresters Falls Drainage Project. Tenders to be received by the Clerk until 1:00 p.m. October 12th, 1971.
