Poss Municipal Council met on the above date in their regular monthly meeting with all members present.

The minutes of former meetings were read and adopted by the Council.

Moved by H. Pilgrim, seconded by George Olmstead that Council make the offer of an increase in salary of \$5.00 per month to Mrs. Beulah Collins amounting to \$55.00 per month and that Council review the work being done in three months.

Pilgrim that Council amend our existing by-law No. 920 which stipulates a charge of $\frac{2}{3}$ of 1 per cent per month interest on tax arrears, to an interest rate of 1 per cent per month to be effective on and after April 1st 1972.
