It was moved by Alvin Stone seconded by Barrie Ross that the following Dog Tax be charged against dog owners for the year 1976. First dog, male or female \$10.00, each additional dog, male or female \$15.00.

Moved by Barrie Ross seconded by Ray Bennett that the Council of the Township of Ross adopt the new 1975 Ont. Building Code and hereby record the Municipal Building By-Law # 905.
