March 1, 1978

The regular monthly meeting of the Ross Municipal Council was held on March 1st, 1978 in the Council Chamber with all members present. Also 2 groups of 4-H Homemaking Clubs were present to observe a council meeting.

Moved by Barrie Ross seconded by Alvin Stone that the minutes of ^{the} February 1st and February 9th¹⁹⁷⁸ sessions be adopted as circulated.

The February 28th minutes were read and adopted and the bills were presented.

Moved by Ray Bennett seconded by Alvin Stone that council pay road voucher No 2 in the amount of \$6,796.05 for the month of February 1978.

Moved by Alvin Stone seconded by Ray Bennett that the Council of the Township of Ross endorse a resolution from the Township of Otonabee requesting the Federal and Provincial members of parliament to control the costs of gasoline and heating oils and gas. That the Governments do their utmost to keep these prices in line with cost of living. Also that copies of this resolution be sent to Provincial and Federal members of Parliament.

Moved by John Bell seconded by Barrie Ross that council agree to send K. Sparling to the "C. Anderson Road School," May 7-10, 1978. Council to pay the registration fee of \$10.00.

Moved by John Bell seconded by Barrie Ross that council approve Road Employees Statutory Holidays as follows:

New Year's	Labour Day
Good Friday	Thanksgiving Day
Victoria Day	Remembrance Day
Domestic Day	Christmas Day
Civic Holiday	Boxing Day

In addition to the Holidays listed above one (1) additional day will be granted to be known as a floating holiday. The date and time for taking such holiday shall be mutually agreed upon by the employer and employee.

Annual Vacation:

(1) Annual vacation may be used after one (1) year of employment.

(2) Date of employment becomes your anniversary date.

(3) The following schedule shall be used to calculate vacation:

(a) Ten (10) working days of paid vacation per year accumulated at the rate of .83 days per month beginning the 2nd year of employment.

(b) Fifteen (15) working days paid vacation per year accumulated at the rate of 1.25 days per month beginning the 6th year of employment.

(c) Twenty (20) working days paid vacation per year accumulated at the rate of 1.67 days per month beginning with the 16th year of employment.

(d) Twenty five (25) working days paid vacation for the 25th year of employment only.

Moved by Alvin Stone seconded by Ray Bennett that the council of the Township of Ross engage Klaus Beimer, as Telfer Officer for the year 1978 at the rate of \$60.00 per month. Plus costs for costs on occasions authorized by the council. Former by-law # 1-77 is hereby rescinded.

Moved by John Bell seconded by Barrie Ross that the council of the Township of Ross authorize A.A. McNeil to offer the Boman Memorial Home \$18.00 per month from March 19, 1956 to July 1971, as agreed by a motion of council on July 3rd 1950. This amount being \$1,170.00.
