Moved by John Bell seconded by Barrie Ross that the council of the Township of Ross make application to the Bank of Nova Scotia at Cobden to borrow money to meet the expenditures of the 4th Line Development Road No. 1285 as they become due and to authorize the Reeve and Clerk-Treasurer to borrow money for this purpose not to exceed the amount of \$90,000.00.

Moved by Alvin Store seconded by Ray Bennett that the council of the Township of Ross hereby adopt the following resolution requesting the C.N.R. work crews and work teams to be more cooperative and thoughtful toward landowners who must cross over railway tracks and sidings as their only access to property for agricultural or other business like purpose.

Whereas it has been known that crossings have been blocked or torn up for 5-6 days or unnecessary length of time.
