James Hunter, representative for Greer, Galloway Associates reported that the water study in Forester's Falls is progressing as authorized by the Ministry of the Environment.

Moved by Ray Bennett seconded by Alvin Stone that Council pay road Voucher No. 8 in the amount of 46,377.89 for the month of Aug. 1978.

Moved by Alvin Stone seconded by Ray Bennett that the Council of the Township of Ross grant Mr. Robert Ford permission to erect a building on pt of East half of Lot 17, Con 1 as requested provided it would be moved upon request of Council in the future.

Therefore Council agree to the construction of such a building at present providing Mr. Ford will sign an agreement to move the structure if necessary in the future.

Moved by Alvin Stone seconded by Ray Bennett that the Council of the Township of Ross request an Ontario Home Renewal Program Grant in the amount of \$39,745.00 for the fiscal year 1978.

Moved by Ray Bennett seconded by Alvin Stone that the Council of Township of Ross pass a resolution accepting the opinion of the Building Inspector regarding Property Standards until such time as an official Plan may be completed by the County Planner, Mr. Looley.

Moved by John Bell seconded by Barrie Ross that the Corporation of the Township of Ross submit to a vote a question under the provisions of the Municipal Elections Act 1977 to the qualified electors is the municipality.

And Whereas the Council considers it expedient and desirable that a vote on the question "Are you in Favour of the Sale of Spirits, Beer and Wine Under a Lounge Licensed Premises?" shall be taken upon the day upon which, under the Municipal Elections Act, a poll will be held at the next annual election of members of Council Nov. 13, 1978.

And hereby authorize the Clerk & Receiver to sign all necessary documents.
