The regular monthly meeting of the Ross Municipal Council was held on March 7, 1979 in the council chamber with all members present.

Moved by John Bell seconded by Jack Ferguson that the February meeting's minutes be adopted as circulated.

The bills were presented. <sup>Representatives were present from Clarkson & Gordon C. explaining</sup> the financial audit for 1978.

Moved by Ray Bennett seconded by Alvin Stone that council pay road voucher no. 2 in the amount of \$14,608.72 for the month of February 1979.

Moved by John Bell seconded by Jack Ferguson that council pay the registration fee for one (1) road employee to attend the C. S. Anderson Road School for \$127.56. This course to run from May 6 to 9, 1979.

Moved by Alvin Stone seconded by Ray Bennett that Council of the Township of Ross submit the sum of \$364.32 to the Renfrew County Agricultural Veterinary Unit, this amount representing Ross Township share towards Provincial Veterinary Subsidy.

Moved by John Bell seconded by Jack Ferguson that council give a donation of \$100.00 to Cobden Agricultural Society to support their Fair held Aug. 23, 24 + 25th, 1979.

Moved by John Bell seconded by Jack Ferguson that the Council of the Township of Ross set the 1979 water rates as follows:

\$10.00 per month for each occupied lot.

\$2.00 per month for each unoccupied lot.

Billings to be three times a year with a penalty clause of 1% after due date.

Water will be cut off after 30 days default.

Moved by Ray Bennett seconded by Jack Ferguson that the council of the Township of Ross appoint Allan James to the Disaster Relief Fund Committee. Council agreed to extend the date for dog tags to May 15, 1979.
