At special meetings in January the following motions were passed:

Moved by John Bell seconded by Jack Ferguson that council pay the Clerk-Treasurer a salary of \$12,000 for the year 1980.

Moved by Alvin Stoe seconded by Ray Bennett that Council of Township of Ross approve and accept a 2% increase in wages for the following Municipal positions:

Assistant Clerk - \$3.69 per hr.

Municipal Hall Custodian - \$112.35 per month.

Waste Disposal - \$83.36 per wk.

Librarian - \$32.10 per wk.

Townsite Supervisor at Hamilton \$6.63 per hr plus \$50.00 per yr. standing.

Building Inspector \$6.80 per hr plus 23% per mile.

Halifax Officer - \$67.20 per month plus 23% per mile.

Moved by Alvin Stoe seconded by Ray Bennett that the Council of the Township of Ross approve the following rate for Municipal Councillors, Deputy-Reeve & Municipal Reeve

Councillors - \$37.45 per meeting

Deputy Reeve - \$37.45 per meeting plus \$250.00 per year.

Reeve - Annual Remuneration twice that amount of the highest Councillor.

Expenses per year member \$250.00 per year plus 23% per mile for mileage while on Municipal business outside the Municipality.

Moved by Alvin Stoe seconded by Ray Bennett that the Council of the Twp of Ross advertise & apply for tenders for the purpose of purchasing an Industrial Type Front End Loader with all tenders to be submitted to the Twp Clerk-Treasurer before 12 o'clock noon Wed. March 5, 1980. Further information & specifications of required equipment are available at the Twp Municipal Office. Lowest or any tender not necessarily accepted.

Tenders will include the trade in value of present Case front-end loader.

Moved by John Bell seconded by Jack Ferguson that Council pass by-law for the purpose of charging a sum of Seventy Five Dollars (\$75.00) to each Lot & Trailer Park for the year 1980.

Moved by John Bell seconded by Jack Ferguson that Council purchase a new calculator for Twp. & Twp Office Supplies for a sum of \$211.86.
