The regular monthly meeting of the Ross Municipal Council was held in the council chamber on September 3rd, 1980 with all members present.

Moved by Alvin Stone seconded by John Bell that the August meetings minutes be adopted as circulated.

A concerned rate payer was present to discuss the dangers of ski-doo's going through his yard.

The County Planner, Gerald Dooley was present to make adjustments to the official plan.

Moved by Ray Bennett seconded by Alvin Stone that council pay road voucher no. 8 in the amount of \$43,477.85 for the month of Aug. 1980.

Moved by Alvin Stone seconded by Ray Bennett that Council of the Township of Ross authorize payment of voucher #8 for the month of Aug. 1980 as follows:

General Account #8 - \$6,510.44

Waterworks Account #8 - 185.68

Total - \$6,696.12

Moved by Alvin Stone seconded by Jack Bell that the Township of Ross enter into an agreement with Forester's Falls Standard Church to install an eighteen (18") inch diameter drainage pipe.

Church to install catch basin on Township allowance and grade the ditch to provide drainage.

After installation of the system, the Township shall maintain all work within the road allowance, the church shall maintain the works located on their property to the satisfaction of the Township and the upstream owners.

And hereby authorizing the Clerk & Reeve to sign said agreement.

Moved by Jack Ferguson seconded by John Bell that By-Law #22-80 be amended as follows: that Part 2 a reference to #49R#922 be purchased from Ontario Hydro at a price of \$500.00. And that the Reeve + Clerk be authorized to sign Agreement of Purchase of Sale.

Moved by Ray Bennett seconded by Alvin Stone that the council of the Township of Ross amend By-Law #22-80 to delete part of paragraph #2 "upon the understanding of the said representatives to establish the said facility before August 1981."

Moved by Alvin Stone seconded by Ray Bennett that the council of the Township of Ross grant the Township Library Board the sum of \$350.00 for the purpose of Library expansion, book filing and book identification.

Moved by John Bell seconded by Jack Ferguson that the council of the Township of Ross petition the Ministry of Transportation & Communications for an Interim subsidy payment on the total road expenditures up to and including August 31, 1980.

Moved by John Bell seconded by Jack Ferguson that council pass a resolution accepting the road in the Mackabone Subdivision Lot 7, Cox 3, known as Macdonald Lane and shown in "Schedule B" and according to agreement signed on June 1978, paragraph 9 Subject to the approval of Ministry of Transportation & Communications.
