The following motions were passed at special meetings in May 1981.

Moved by John Bell seconded by Jack Ferguson that the Minister of Housing modify the Land Use Map by changing Lot One (1) Concession Area (A) from Rural Agriculture and Forest Resource to Rural Marginal.

Moved by Alvin Stone seconded by Ray Bennett that the Minister of Housing modify the Official Plan by adding the following paragraph to Section E 2 (2) (c) Land Severance Policies:

"An exception, consent or seasonal residential lots along the waterfront, not abutting an existing open public road allowance will be granted provided:

a) the proposed seasonal lot is rezoned to a separate classification prior to consent,

and

b) the proposed seasonal lot abuts a sixty-six (66) foot private right-of-way or access to an open public road allowance.

Moved by Alvin Stone seconded by Ray Bennett that council of the Township of Ross purchase a new 21" Deluxe self propelled Lawn Boy mower for the sum of \$325⁰⁰ plus tax from Toy's Marine (Reflex) on per estimate submitted by caretaker, Allan Collins.

Moved by Jack Ferguson seconded by Ray Bennett that council give approval to the Orange Lodge of Foresters Falls for a Fund Raising Dance July 11, 1981 between the hours of 8:30 P.M. & 1 A.M.
