Moved by John Bell seconded by Jack Ferguson that the August minutes be adopted as circulated and read.

A ratepayer was present to bring to the attention of Council a smoke and junk yard problem. Council agreed to look into the problem.

Moved by Ray Bennett seconded by Alvin Stone that Council pay road voucher # 8 for the month of Aug. in the amount of \$10,234.53

Moved by Alvin Stone seconded by Ray Bennett that Council for the Township of Ross approve payment for the following voucher # 8 for the month of August 1982.

Voucher # 8 Waterworks Account 99.90

Total \$10,238.80

Moved by Alvin Stone seconded by Ray Bennett that Council for the Township of Ross approve a grant for the sum of \$500 to the Renfrew County Plowmen's Association.

Moved by John Bell seconded by Jack Ferguson that Hubert Gilmore be paid \$600 for each Pennel Licenses sold.

Moved by Alvin Stone seconded by Ray Bennett that Council for the Township of Ross continue to pay the Renfrew County Levy in two (2) installments per year.

Moved by Jack Ferguson seconded by John Bell that Council do not pay insurance for Queen's Sir's Honor's Institute on their Building, Forester's Falls rink, concession booth at Bell Field and Holy Link concession booth.

Moved by John Bell seconded by Jack Ferguson that Council shall notify the Municipal Law Enforcement Officer of the building violation by Tom Hardy, after consulting our solicitor, David Stewart.

Moved by John Bell seconded by Jack Ferguson that Council give first and second reading to a By-Law that shall apply Site Plan Control.

The provisions of this By-Law shall apply to all lands within the Corporation of the Township of Ross zoned as Tourist Recreation.
