The regular monthly meeting of the Ross Municipal Council was held on November 3rd, 1982 with all members present.

Moved by Ray Bennett seconded by Jack Ferguson that the minutes of the October meetings be adopted and circulated.

A request was heard regarding fencing along a Township Road. Council explained the Township policy of paying $\frac{1}{2}$ the cost of the wire. It was the decision not to make an exception to the policy.

Council are requesting Ted Irving from M.T.C. to attend a council meeting to explain the new subsidy formula.

Moved by Alvin Stone seconded by Ray Bennett that council for the Township of Ross authorize and appoint the Reeve and Deputy-Reeve ^{+ spouses} to attend the Renfrew County Travel Association's annual meeting to be held in Eganville Legion on Friday December 3rd, 1982 with the Municipality to pay the required registration fees of \$10.00 per person.

Moved by Ray Bennett seconded by Alvin Stone that the council for the Twp. of Ross approve and submit a grant for the sum of \$375.00 to the Ross Twp. Recreation Committee.

Moved by Alvin Stone seconded by Ray Bennett that council for the Township of Ross approve and pay General Account Voucher #10 for the sum of \$127,074.56 and Waterworks Account Voucher #10 for the sum of \$48.45.
Total \$127,223.01

Moved by Ray Bennett seconded by Alvin Stone that council pay Road Voucher #10 in the amount of \$9436.44 for the month of October 1982.

Moved by Alvin Stone seconded by Ray Bennett that the council of the Township of Ross authorize the Reeve and Clerk to prepare resolutions for Federal funding for McLeod Drain and authorize the Clerk to forward same to Minister of Industry and Regional Expansion, Hon. Ed Lunney, and Local M.P. and M.P.P.

Council received copies of the expenditures to Oct. 31/82. The Clerk gave a brief explanation.

The Reeve remuneration will be as follows: Twice the amount of the highest paid councillor plus \$250⁰⁰ travel expenses.

Moved by Ray Bennett seconded by Alvin Stone that the Council of the Township of Ross shall charge \$10.00 to shut-off or hook-up any water supply to any residence upon a request to the Townworks Superintendent.
