Moved by Stanley Black seconded by Alvin Stone that the council of the Township of Ross accept the tender of Edward Smagliniski for the position of operator of the Waste Disposal Site for the twelve months beginning Feb 28/83 and ending Feb 29/84 for the sum of \$8,500.00 to be paid in 12 equal monthly instalments.

After a lengthy discussion it was decided that a building permit would be issued to Stan Hendry stating that no other structure shall be closer than 80 ft from the road. Any other building shall be removed as provided in By-law # 8-82.

That Be It Resolved that the Ross Township Council request the Kenora County Road Department to take over the Grant's Settlement Road, from County Road #7 at Lot 10, Cox 9 generally northerly direction, a distance of approximately 9.9 km to the line between Lot 1, Cox 849 at the Township of Ross and Westmeath Townships.
