The regular monthly meeting of the Ross Municipal Council was held on January 4th, 1984 in the Council Chamber with all members present. Felix Rathwell, Road Superintendent and Jim & Margaret Horton were also present.

Moved by John Bell seconded by Jack Ferguson that the December meetings minutes be adopted as circulated.

Alvin Stone reported that suggested date for the Township Bicentennial Days be Aug. 3rd to 6th. Letters are being prepared to send to organizations throughout the Township for their co-operation. Mr & Mrs Horton were interested in getting an advertisement in their annual newsletter giving dates for the celebrations in Ross Township.

Council were advised that the totals paid Dec 31, 1983 on the General Voucher was \$210,776.01, Road Voucher \$15,558.79, Waterworks Voucher \$382.22 which were authorized Dec 15/83 for payment by December 31, 1983.

Ontario Hydro street light rates for 1984 shall be \$574.03 to be paid quarterly.

Moved by John Bell seconded by Jack Ferguson that the Council of the Township of Ross make application to the Ministry of Transportation and Communications for the balance of the 1983 subsidy.
