The regular monthly meeting of the Ross Municipal Council was held on October 3rd, 1984 in the Council Chambers. Reeve Alder May chaired the meeting and present were Deputy-Reeve John Bell, Councillors Stanley Black, Jack Ferguson and Alvin Stone, Road Superintendent Felix Kattwell.

Moved by Stanley Black seconded by Alvin Stone that the September minutes be adopted as circulated.

A Ratepayer expressed concern about a sign posting the name of "Jeffery Lake Road," Council agreed to have it changed to "Olmstead Lake Road".

Reeve May welcomed Ogeongo student, Marsha Dagg to observe a Council meeting in progress.

Moved by Alvin Stone seconded by Stanley Black that Council pass a resolution to accept the contract price of \$10,032.00 from Len Chapeskie for the removal of old cement culvert and to install & supply fill & tamp & bring the road up to grade on Jug Rd known as Ken line between lots 8 & 9, 2411.

Moved by Alvin Stone seconded by Stanley Black that the Council of the Township of Ross approve payment of Road Voucher #9 for the month of September 1984, in the amount of \$11,335.09.

Green, Galloway requested Council to make their final inspection of the Millard Municipal Drain at 11 AM, October 11th, 1984.

Correspondence included a letter from the Ministry of Consumer and Commercial Relations requesting Council's attention to the overgrowth at the abandoned cemetery on Part of Lot 6, Con 3. Council agreed to include it in the 1986 budget.

Council approved severance for Clarence S. Cybulskie & Sons Forest Products Ltd. File No. B284/84.

Moved by Alvin Stone seconded by Stanley Black that Council for the Township of Ross accept the Tile Drainage Loan application from Ellard Powers in the amount of \$2,880.00.

Moved by John Bell seconded by Jack Ferguson that the Council of the Township of Ross adopt and support the resolution submitted by the Corporation of the Village of Zurich on regulations and terms concerning Waste Disposal sites. Copies to go to members of Parliament.

After the injection of the 7th Local Municipal Drain and the annual road tour on October 11, 1984 all Council members met and the following motion was passed.

Moved by Alvin Stone seconded by Stanley Black that Council rescind By-Law # 58-84 and replace it with the following:

That Council pass By-Law # 59-84 to accept the contract price of Len Chyzoski for the removal of old culvert and necessary material around old culvert and to install new culvert and haul and pack the necessary Grandular C to bring road up to grade on Township road known as New Line between Co 889 Lot 11. Contract price to be \$10,032.00. Council approve advance payment of \$5,000.00 as work is completed.

Moved by Alvin Stone seconded by Stanley Black that be it Resolved that Council agree in principal to the Hilliness Township Site Plan as presented to Council October 29, 1984 by Glen Galloway representative Jim Hunter. Council will meet on November 6, 1984 to deal with this matter.

Moved by Alvin Stone seconded by John Bell that Council for the Township of Ross accept the invitation from Cobden Legion to have a wreath placed on November 11, 1984 by Councillor Stan Black. And the sum of Twenty Dollars (\$20.00) be forwarded to the Cobden Legion for this purpose.
