Moved by McLaughlin, seconded by Rathwell that Council of the Township of Ross give three readings and pass By-law #18-97, being a By-law to adopt the estimate of sums required during the year and strike the rates of taxation for the year 1997.

THEREFORE, the Council of the Corporation of the Township of Ross stresses that any such restructuring proposals be done with the full knowledge of and with the agreement of any Municipalities involved, including especially the County of Renfrew. Council decided to send two representatives to Cobden to hear the proposal from the

Town of Renfrew on setting up a permanent Hazardous Waste Depot.

TEMPORARY CONSTRUCTION USE AGREEMENT

- By way of this agreement, the Corporation of the Township of Ross and property owners Blake Carson and Heather Hyatt agree to the following:
- Blake Carson and Heather Wyatt have requested that the existing house on their property at S.Pt. Lot 3, Con. 1 EML be used as a place of residence during construction of their new dwelling. By-Law 23-92, Section 3.7 "Dwellings per lot" permits no more than one dwelling unit per lot. The Township agrees to allow this house to remain on the site as a temporary construction use as per Section 3.27 "Temporary Construction Uses", providing they obtain and pay for a demolition permit and the house is removed from the site immediately following occupancy of the new dwelling.
- The house shall be removed on or before the 31st day of October, 1998. If construction is delayed and the property owner is unable to occupy the new dwelling by October 31st, 1998, the property owner may apply in writing for an extension beyond this date. However, if no reasonable cause is demonstrated to the Council of the Township of Ross why the house should not be removed the Council shall have the authority to have the house removed at the property owners expense.
