
The Clerk will place an ad in the local paper asking Ross Township Students to register with Manpower, and the Committee will choose workers from that list for the Summer Student Career Program.




The Notice of Public Hearing was read by the Clerk, and it was stated that every person assessed within 60 metres of the property was notified by letter, and no objections were received.

It was moved by Rathwell, seconded by Ferguson that the Committee of Adjustment approve the following decision for File No. A 03-97:

THAT the minimum requirement contained in subsection 3.24(a)(ii) of the Setback requirements from 60 metres to 20 metres. The purpose of the minor variance is to permit a dwelling on a lot to be created by B61/97.

The Notice of Public Hearing was read by the Clerk, and it was stated that every person assessed within 60 metres of the property was notified by letter, and no written objections were received. However there were verbal objections from those present and the following motion was passed by the Committee of Adjustment:
