WHEREAS the County of Renfrew 9-1-1 Emergency Service has deemed it necessary to rename roads within the County of Renfrew and to ask Municipalities to name all existing roads for 9-1-1 purposes;
AND WHEREAS the Council of the Township of Ross has named all municipal, and private road names within the Township of Ross;
AND WHEREAS the Council of the Township of Ross has adopted the Township of Ross 9-1-1 Road Naming Committee proposals for road naming purposes;
AND WHEREAS the Council of the Township of Ross accepts the "Haley Road" name for historical reasons for the road from Highway 17 through Haley Station to Highway 60:

THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ROSS adopts the name "Haley Road" for the road from Highway 17 through Haley Station to Highway 60;

FURTHER requests the Admaston Council to adopt the Township of Ross recommendation and change "Rosebank Road" to "Haley Road"; AND FURTHER THAT a copy of this resolution be sent to Admaston Council for their Township of Ross consideration.

Moved by Ferguson, seconded by Rathwell that the Council for the Corporation of the Township of Ross give the first and second reading of By-Law # 21-97 being a by-law to provide for the Township of Ross to rename certain Municipal Roads (Highways) under its juriship of Ross to the 9-1-1 Civic Addressing Project for the County of Renfrew.

Moved by Ferguson, seconded by Gibson that the Council for the Township of Ross hereby accept the quote by invitation from Greenwood Paving (Pembroke Ltd.) to supply and place one layer of HF 150 asphalt emulsion with 5/8" Class II aggregate and supply and place a top layer of HF 150 asphalt emulsion with H.L.#3 stone aggregate surface at the price per kilometre at \$10,250.00 plus G.S.T. for the remaining portion of Number One Side Road from Hwy. 17 to the Fourth Line and the whole of Hill Side Road the whole of Hill Side Road.
