Moved by Campbell, seconded by Rathwell that Council of the Township of Ross approve the payment of \$200.00 to the Restructuring Committee to cover costs of meetings.

A letter was received from the Ministry of Environment and Energy stating that there were no concerns involving a property at the Townsite which has recently gone through the Tax Sale process. Therefore Council authorized staff to have the property vested in the name of the Township of Ross.
