Moved by Ferguson, seconded by Rathwell that Council of the Township of Ross give three readings and pass By-Law #06-98, being a by-law to provide for interest to be applied on tax arrears and penalty on unpaid taxes in the current year.

Moved by Campbell, seconded by Ferguson that Council of the Township of Ross give three readings and pass By-Law #07-98, being a by-law to provide for implementation and collection of an interim tax levy for 1998.

Moved by Ferguson, seconded by Rathwell that the meeting be adjourned at 10:15 p.m. and the next regular meeting will be held on March 4th, 1998 at 7:30 p.m. in the Council Chambers.
