Reeve Stone called the meeting to order at 8:00 p.m. and led in repeating The Lord's Prayer. The minutes of the March 4th meeting were adopted as circulated.

E.Mac Fraser was present and also sent a letter requesting that his property at Lot 3, Con 1 WML be considered for Commercial zoning so a new and used clothing store could be opened on May 1st. AND WHEREAS the Township of Ross has been in discussion with the Townships of Bromley and Westmeath, and the Villages of Beachburg and Cobden for some time to review the possibility of amalgamation

THEREFORE BE IT RESOLVED that the Council of the Township of Ross upon reviewing all available documentation strongly agree to enter into an amalgamated municipality along with the other committed Municipalities.

Moved by Chapeski, seconded by Ferguson that Council of the Township of Ross approve payment of Registration fee and expenses to the Association of Tax Collectors of Ontario Spring Seminar in Peterborough on May 3 -5 for Deputy-Clerk.

Moved by Chapeski, seconded by Ferguson that the Council of the Township of Ross pass the following resolution:

WHEREAS the responsibility of the septic system function has been delegated by the Ontario Government to the Lower Tier Municipality under the Ontario Building Code;

AND WHEREAS this service would be delivered by different persons and agencies and have various interpretations under the Lower Tier;

THEREFORE BE IT RESOLVED that the Township of Ross request that the Septic System inspection function be provided by the County of Renfrew.

Moved by Campbell, seconded by Rathwell that Council of the Township of Ross give three readings and pass By-Law #08-98 being a by-law to set wage schedule for employees.

Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross give three readings and pass By-Law **#09-98** being a by-law to set remuneration for members of Council.

Moved by Rathwell, seconded by Campbell that Council of the Township of Ross give three readings and pass By-Law #10-98 being a by-law to appoint a Drainage Superintendent.

Moved by Chapeski, seconded by Ferguson that Council of the Township of Ross give three readings and pass By-Law #11-98 being a by-law to re-zone land located within Lot 16, Concession 2 (Peterson).

Moved by Campbell, seconded by Rathwell that Council of the Township of Ross approve an application from E.M.Fraser for a zoning By-law amendment at part of Lot 3, Con 1 WML, from Rural to General Commercial to permit a new and used clothing store.

Further that the Staff be authorized to procure the services of the County Planning Department to prepare the necessary by-law and advertising.

Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross make application to the Disaster Relief Fund of Ice Storm '98 for the estimated amount of \$9249.00, for clean-up of trees and brush.

Moved by Chapeski, seconded by Campbell that the meeting be adjourned and the next regular meeting will be held on April 8th, at 7:30 p.m. in the Council Chambers.
