Moved by Campbell, seconded by Rathwell that Council of the Township of Ross approve the purchase of a photocopier from Buske Office Equipment for \$4500.00 less trade-in allowance of \$1700.00. Total cost \$2800.00 plus applicable taxes. Also the Township of Ross will use the Service plan at .019 cents per copy.

Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross support a resolution from the Township of Horton petitioning the Province of Ontario to remove levies such as fraud and homicide investigations from Municipality responsibility.

Moved by Chapeski, seconded by Ferguson that Council of the Township of Ross make application through Summer Jobs Service, Algonquin Training Centre, for funding for two students for 8 weeks each. The program provides \$2.00 per hour wage subsidy.

The Town of Renfrew has been granted approval for a permanent Hazardous Household Waste Facility at their landfill site. They are prepared to pay the capital cost of setting it up and will enter into agreements with municipalities who would like to use the facility and share the operational and maintenance costs on a population percentage. Council agreed to send a representative to a meeting to discuss this issue.

Council decided to ask the firm William Squibb & Associates to come in for a review later in the fall, with the aim of making a tax recovery.

The list of applicants for summer jobs was short listed, and interviews will be scheduled for Wednesday evening June 24th to choose three students.

The Road Committees of Ross and Westmeath met on June 15th where Westmeath requested that the Townline receive a hardtop application. Council agreed they would put together a plan of priorities, but it could not be paved this year.

Moved by Campbell, seconded by Chapeski that the meeting be adjourned and the next regular meeting will be July 8th at 7:30 in the Council Chambers.
