AND WHEREAS some of the highways transferred from the province to municipalities are in very poor conditions; AND WHEREAS the one time only funding given to municipalities to maintain and up-

keep these newly acquired sections of highway is very inadequate; NOW THEREFORE BE IT RESOLVED that the Municipal Council of the Corporation of the
