The purpose of this application is to amend the Official Plan include this area in Special Tourism Area 3 and change the zoning from Agriculture to Tourism Commercial to permit camping and parking.

Moved by Chapeski, seconded by Ferguson that Council of the Township of Ross give three readings and pass By-Law #42-98, being a by-law to amend By-Law #04-98 as relates to part of the unopened road allowance between the Township of Ross and the Township of Horton.

Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross accept the tender price of \$275.00 per month from Doris Reaney for Caretaking services of the Municipal Office and Chambers effective January 1, 1999. And further that staff will prepare a Contract Agreement between the successful applicant and the Township of Ross.

Moved by Rathwell, seconded by Campbell that Council of the Township of Ross purchase an advertisement from Lorne Spotswood for \$129.00 to be placed in the 1999 Four Season Guide.

Moved by Campbell, seconded by Rathwell that Council of the Township of Ross transfer the amount of \$30,000.00 from the 1998 Budget Surplus into Reserve for Sick Leave.

Rathwell read a letter written by Co-Chairpersons for the Municipal Restructuring Committee, Art Cobb and Don Rathwell to the Village of Beachburg stating their disappointment that they did not adopt the restructuring proposal, and their hope that they would reconsider before the next meeting on January 18th.

On the recommendation of the Auditor of the Township of Ross, the Reeve is to initial all road invoices while the Road Superintendant is off on sick leave.

The Township office will be closed for Christmas on December 24th, 25th and 28th.

Moved by Chapeski, seconded by Campbell that the meeting be adjourned at 10:00 p.m. and the next regular meeting will be held on January 6th, 1999 in the Council Chambers.
