Reeve Stone called the meeting to order at 7:30 p.m. and led in repeating The Lord's Prayer. The minutes of the January 6th meeting were adopted as circulated. The Agenda were approved as amended.

Moved by Rathwell, seconded by Campbell that Council of the Township of Ross give three readings and pass By-Law No. 01-99, being a by-law to pay memberships for the year 1999.

Moved by Chapeski, seconded by Rathwell that Council of the Township of Ross give three readings and pass By-Law No. 02-99, being a by-law to provide for participation of the Volunteer Fire Department in the County Mutual Aid Plan.
