Moved by Ferguson, seconded by Campbell that the Township of Ross pass the following resolution:

WHEREAS the Township of Ross have had a Road Employee for a number of years on a Permanent Part-time basis;

AND WHEREAS Council wish to upgrade this employee to qualify for benefits;

THEREFORE BE IT RESOLVED that Council of the Township of Ross change the status of Road Employee, Lorne Rathwell to permanent full time Road Employee with full employee benefits.

This resolution to become effective July 1, 1999.

It was discussed as to whether trailer camps should pay a licence fee determined by the number of lots available, but Council felt that some camp fees would have a great increase, therefore a by-law will be introduced at the next meeting setting fees at separate rates for under and over 100 lots.

Bruce Beakley will be contacted to acquire a job description for a Truck Driver/Equipment Operator and it will be brought to the next meeting and a decision will be made when to advertise for a Road Employee.
