The regular meeting of Ross Municipal Council was held on February 2nd, 2000 in the Council Chambers.

Present were Reeve Alvin Stone, Deputy-Reeve Jack Ferguson, and Councillors Don Rathwell, Donna Campbell and Teresa Chapeski.

Reeve Stone called the meeting to order at 7:35 p.m. and led in repeating The Lord's Prayer. The minutes of the January 19th meeting were adopted as circulated.

Moved by Campbell, seconded by Rathwell that Council of the Township of Ross approve General Account Voucher # 1 for \$79,169.47 and Waterworks Voucher # 1 for 467.96 for the month of January, 2000.

Keith Blimkie, Chief Building Official for Ross Township, presented the Year End Summary Building Inspection Report for 1999. It showed that the Permit fees paid for the Inspections but there was an extra cost of \$1529.00 for his cellular

There was discussion concerning a request from Margaret Maloney owner of The Enchanted Gardens, for a 'change of use' building permit to allow the London House to be used as a tea room and gift ship. Council agreed that a letter be drafted stating that she would be required to consult a professional engineer to establish the requirements to meet the Ont. Building Code for it's intended use.

In further discussion on Spratt Lane, Campbell said that there is a steep hill and it is not safe to go through it in winter, but she thought that the road was named properly as Spratt Lane both in Ross and Horton.
