Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross pass the following resolution:

WHEREAS, the Transition Board have come to a stalemate with respect to the future Administration Building for the Township of Whitewater Region;

AND WHEREAS, a new office concept strategically located as close as possible to the geographic centre of the new Municipality would be the most desirable for the delivery and receiving of customer services;

AND WHEREAS, there would be significant benefits for the Administration Complex to be located adjacent to other Municipal assets, with direct access to Municipal and County roads that would serve the residents and visitors, and with direct access to the future proposed 417 Freeway Highway;

AND WHEREAS, land is available at the Ross Roads Garage site at the corner of Mineview Road and County Road # 7 that would meet all the above requirements;

THEREFORE BE IT RESOLVED THAT the Township of Ross recommend that the Transition Board seriously consider the implementation of an Interim administration to satisfy immediate needs.

AND FURTHER BE IT RESOLVED THAT the long term administration would be strategically planned to complement a new office structure for the new and vibrant Whitewater Region complex.

Moved by Ferguson, seconded by Chapeski that Council of the Township of Ross give three readings and pass By-Law No. 12-2000, being a by-law to erect a stop sign at the intersection of Boxcar Road and Calvin Road.

Expenses will be paid for the Deputy-Clerk to attend the Tax Collector's Spring Seminar on May 7th, 8th and 9th in Toronto-Markham.
