A Special meeting of Council of the Township of Ross was held on October 26th, 2000, to discuss a Waste Management issue and other urgent business.

Present were Reeve Alvin Stone, Deputy-Reeve Jack Ferguson, and Councillors Don Rathwell, Donna Campbell and Teresa Chapeski.

Reeve Stone called the meeting to order at 1:00 p.m.

There were twelve persons present representing Ross Township Ratepayers, members of Whitewater Ratepayers Association and Ross Roads Leadhand, to address Waste Management issues.

Councillor Chapeski read a letter she had sent to Clarence Barron and Jeannie Brown regarding temporary control measures she had put in place to prevent waste from neighbouring Municipalities entering the Ross Township Waste site. Councillor Chapeski assigned Roads Lead Hand Darwin Peever to unlock the waste site when Barrons had need to enter for dumping or covering.

The delegation had several complaints of illegal garbage entering the site, hazardous waste and appliances with freon being buried and propane tanks lying around the site. They demanded that Barrons lose their contract.

Since there is only a little over two months before new regulations are in place in the new Municipality, Council suggested that Darwin regulate the site on week days and they hire someone else for Saturdays. Since Barrons were away on vacation, they were not present to answer to allegations.

There were several phone calls this week to office and Council members concerning water pressure at the Townsite. Greg Davidson was present at this meeting to explain what procedures he has implemented and to discuss what could be done to remedy this situation. It could be up to \$10,000 for an alarm system (analyzer) and if both wells were in operation this would be doubled. It was decided that a meeting should be arranged with townsite residents and perhaps get Ed Gardner of the Health Unit or Brad Eckert of the MOE to attend and explain the regulations.

Since an All-Candidates meeting for Municipal Elections will be held on the evening of the next regular meeting, it will be held at 1:00 p.m. Nov. 1st.
