Auditor Tom Foran was present to review the year 2000 Budget to date and to instruct Council as to what action should be taken before year end to make a smooth transition into the new Municipality of the Township of Whitewater Region.

Study and application to be filed prior to January 31, 2001.

Moved by Rathwell, seconded by Campbell that Council of the Township of Ross pass the following resolution:

WHEREAS the employment agreement with the Clerk-Treasurer has provisions for compensation of Council meetings necessary for the administration of Municipal business:

WHEREAS in the years 1999 and 2000 the Clerk-Treasurer was required to participate in numerous meetings of the Transition Board and was recording secretary for the Protection to Persons and Property Sub Committee meetings for Restructuring;

AND WHEREAS the Clerk-Treasurer has chosen to retire as of December 31, 2000 and will not be able to take the accumulated time off in lieu;

THEREFORE BE IT RESOLVED THAT Council of the Township of Ross approve payment to the Clerk-Treasurer of \$2172.80 representing ninety-seven (97) hours accumulated over and above normal working hours.
