BY-LAW

No 183

Whereas W. H. Campbell gives notice of a By-Law authorizing the Village of Beachburg to enter into an agreement with the Township of Westmeath to erect a community center,

Moved by W. A. Bennett and W. H. Campbell the by-law authorizing the village of Beachburg to enter into an agreement with the Twp of Westmeath be now introduced and read a first time.

Moved by W. A. Bennett and W. H. Campbell that the by-law authorizing the village of Beachburg to enter into an agreement with the Twp of Westmeath with the blanks filled in as follows:

Whereas the village of Beachburg desires to join with the Twp of Westmeath in the erection of a Community Centre: and

And Whereas the village of Beachburg and the Twp of Westmeath have agreed to the terms of the Agreement hereto attached and forming part of this by-law.

Now therefore the Municipal Council of the Corporation of the Village of Beachburg enacts as follows:

1. That the Village of Beachburg shall enter into the within agreement dated the 21st day of October, A. D. 1964 between Beachburg and Westmeath.

2. That the Reeve and Clerk are hereby authorized to sign and execute the same on behalf of the Corporation of the Village of Beachburg.

Read a second time and passed this 21st day of October A. D. 1964.

Read a third time ^{unanimously} and finally passed this 21st day of October 1964.
