

January 25, 1994

The Council of the Corporation of the Village of Beachburg met on the above date at a Special Meeting, with everyone present.

Moved by Jim Labow and seconded by Grant Somerville that the Council of the Corporation of the Village of Beachburg hereby petition the Ministry of Transportation for subsidy for road expenditures in the amount of \$70,573.08.

Reeve Jamieson was called away to a barn fire at his farm. The remainder of Council also went to the fire but returned later.

Reeve Gordon White, Deputy Reeve Robert Gervais and Councillor Mary Ann Olsen arrived at Council and discussed the Welfare Administrator problem since Mrs. Kenny had also been their Welfare Administrator and had resigned both jobs. It was decided to advertise for a joint Administrator again and both clerks are to short list the applications. It was decided that Westmeath would have 3 people on the hiring Committee and that Beachburg would have two. Westmeath Council then left.

It was decided that Reeve Jamieson and Councillor Labow would be on the hiring committee.

The meeting then adjourned.

The Council of the Corporation of the Village of Beachburg met on the above date at the Municipal Office.

The meeting was called to order again and the Correspondence Presented:

1. From C.N.R., a letter advising Council that clearing the snow from level crossings was the Municipality's responsibility.
2. From C.N.R., a letter stating that the level crossing at mileage 73.20 in the Village of Beachburg required major repairs in 1994 and further stated that C.N.R. had chosen to rebuild the crossing with a paved surface and conventional flangeways. If the Municipality wished a better quality they would have to be responsible for the extra costs. Council decided to go along with the C.N.R.'s choice.
3. From Ted and Daphne Barron, a card of thanks for flowers at the time of their son's death.
4. From Warden Alvin Stone, a note of thanks for the flowers and Reeve Jamieson's delivery of them.
5. From Campbell McKie, notice of Lucio Appollon's retirement and an invitation to a retirement celebration to be held in Renfrew on March 25, 1994.
