CORRESPONDENCE PRESENTED:

1. Two cards of thanks, one from Mrs. Beulah Wright and one from her family, for flowers received on the death of her mother.

2. From Mr. Stan Whalley, a letter concerning the traffic on Cameron Street and a suggestion that a three way stop be authorized at the corner of Malcom and Cameron Streets. Council to consider this suggestion and the Clerk is adised to ask Mr. David Norlock from M.T,O. to look at this corner and also to look at Vera Crescent, because it is very rough and Council is not happy with it.

3. From the County of Renfrew, a copy of the County's Draft brief on Bill 20.

4. From the County of Renfrew, a copy of a letter from the Petawawa Amalgamation Committee asking if members of County Council would meet with this Committee on March 21 in Petawawa, regarding the number of votes at the County level for an amalgamated municipality and also a concern that there be no shift of levy apportionment. 5. From the Ministry of Transportation a letter stating that the Village would receive \$2500, which is the amount of 1995 Supplementary Subsidy allocation which was held back in 1995. This money may be spent on any roads expenditure or may be used to pay 1995 bills.

6. From the Ontario Provincial Police, copies of the Criminal incidents which occurred in the Village in 1995.

7. From the Corporation of the Village of Barry's Bay, a list of surplus street lights which they have for sale.

8. From the Pembroke & Area Waste Management Board, copies of the Waste Management and Household Hazardous Waste Budgets.

The Clerk advised Council that she had been speaking to Mrs. Eleanor McLaughlin, from the North Renfrew Agricultural Society and she stated that they were not holding a Horse Race this year and she wondered if Council would donate to another event, such as the Tractor Demonstration. Council agreed to donate \$100.00.

Moved by Grant Somerville and seconded by Jim Labow that the Council of the Corporation of the Village of Beachburg hereby approves of the North Renfrew Agricultural Society applying for a liquor licence(Special Occasion Permit) for the Beachburg Fair on July 26,27 and 28, 1996. The Council hereby designates this event to be a Community Festival of significant value to the Community. Carried.

It was decided that Councillor Wright should draw up a letter to Mr. John Woods, on behalf of Council, stating that the Village would pay him a flat rate of \$150.00 per month, for animal control and that all fines collected by the Village would be paid to him He would also keep \$5.00 per dog tag sold after January 31st.

A letter had been received from Mr. Barry Riddell showing how many of his apartments had been vacant over the past year and asking for a rebate for 14 months water. Council decided against this rebate.

It was decided to bill Mr. Delmer Lavallee for a water hook-up at his new house on Malcom Street.

Increasing water rates was discussed after Council looked over the Financial Statement.

Moved by Grant Somerville and seconded by Jim Labow that the Corporation of the Village of Beachburg hereby set new water rates, to be as follows: Residential rates \$400.00 per annum,(i.e. \$100.00 per quarterly billing), with a late payment charge of 5% (five percent) per billing. Businesses will be charged the same percentage increase. These rates will be effective July 1, 1996. Carried.

Reeve Jamieson spoke to Council on County Council Government and stated that Council would be asked for a letter with suggestions on how to improve CountyGovernment.

The Clerk is advised to call Mr. David Norlock from M.T.O. to come and look at Vera Crescent and also to look at the Corner of Cameron and Malcom to see what could be done about traffic at this corner,

Moved by Grant Somerville and seconded by Jim Labow that this meeting of the Council of the Corporation of the Village of Beachburg hereby adjourn until April 9, 1996. Carried.
