Corner Convenience and Jamieson Lane for the safety of the children and the walkers of
the Village.

The Clerk was advised to send them a letter stating that it would be considered during the Spring Roads Tour and also if the Budget would allow. Main Street is a County Road so approval would also have to be received from them. 2. From the Waste Management Board, copies of the Waste Management Board Budget, also the Re-Cycling Budget and Composting and Houshold Hazardous Waste Budgets.

Moved by Grant Somerville and seconded by Jim Labow that the Council of the Corporation of the Village of Beachburg hereby approve the 1998 Waste Management Board Budget in the amount of \$4805.00 for the Village of Beachburg and also approves the Household Hazardous Waste Budget in the amount of \$351.00. 4. From the County of Renfrew and Janota Patrick, letters regarding Septic System inspections.

Moved by Ron Lowe and seconded by Jacob DeWal that the Council of the Corporation of the Village of Beachburg hereby enter into a service agreement with the County of Renfrew to perform septic system inspections. Carried.

5. From the County of Renfrew, re Special Circumstances Fund and advising local Municipalities to apply for funding as well as individuals.

6. From the N.R.A.S., a letter asking for a donation for the tractor pull to be held at the Fair this year. Council decided to donate \$100.00, the same amount as last year. The 1997 Financial Statement was discussed and it was noted that there was a deficit

of only \$369.00. Moved by Jim Labow and seconded by Jacob DeWal that the Council of the Corporation

The Clerk was advised to put in a bill to the Special Circumstance Fund for our Hydro Bill from Renfrew Hydro for their work during the Ice Storm and also for the Firemen's wages and wages for Shane & Greg for their extra work.

Councillor DeWal brought up the subject of pot holeSand the condition of the roads which were newly finished with tar and chips last fall and Councillor Labow stated that Greenwood Paving would be coming down to re-do these streets. Counc. Somerville stated that he had three quotes for a new half-ton for the Village and that he beleived that Renfrew Chrysler had the best financing. Reeve Jamieson brought up the subject of Amalgamation and discussed the meetings he and other Council members had attended and the following resolution waspassed:
