Reeve Jamieson called the meeting to order at 7:00p.m., withoeveryone present. Moved by Jacob DeWal and seconded by Ron Lowe that the minutes be adopted as circulated. Carried.

Mrs. Fewer and Mrs. Pellerin and Constable Graves from the O.P.P. had all arrived at Council.

Mrs. Fewer stated that she had caught 7 skunks in a trap at her property and stated that she had 2 skunks living under her deck. She also had photgraphs of the animals. She wonder what Council was going to do about the situation. Council agreed to take away the skunk that is presently in the trap and to try to purchase a trap for future use. Council also agreed to pay the rental for her trap. Mrs. Pellerin also stated that she had skunks at her property, but that she was coping with them. Mrs. Fewer and Mrs. Pellerin then left.

Constable Graves asked Council if there were any problems for the O.P.P. and Reeve Jamieson mentioned that calls had been receivedabout vehicles not stopping at the corner of Little and Elliot Streets, which has a 4 way stop. Sept.8, 1998 Business:

1. Phyllis brought up some concerns of Shane, he stated that decks and sheds of under 100 sq. feet are not regulated by the Municipality but must meet the Ontario Building Code standards and he wondered if Council wished to regulate these buildings by permits or inspections. Council decided to do nothing.

Shane had also stated that the 1/2 ton truck is badly in need of repairs and he wanted to know if we should repair it or keep it running until something other comes along. Council decided to just keep it running for now.

Shane had also given the Clerk a copy of a 5-day course which he would liketo take on Health & Safety in the house. It is a 5-day course being held in Kanata. Council agreed that he could attend.

2. Councillor DeWal stated that there is a policing meeting being held in Westmeath on Sept.16, regarding scams and frauds. He stated that it was mostly for seniors.

3. Councillor Lowe asked about the Medical Centre and stated that the Board would need financial help after the end of the year. He asked the Councillors to consider ways to help. Ron is advised to call Mrs. Bonnie Johnson who works at the clinic in Lanark to see how it operates.

4. Councillor Labow presented Greg's estimate for drainage work onWatchorn and Anderson Drives, in the amount of \$8,260. The clerk advised that there is \$9,000 in Reserves for Roadways. Council decided to use that money. Council stated that they would pass a resolution regarding this before December31, 1998. Councillor Labow also stated that he had a quote of \$3,000 for a snow blower if we trade in the old one.
