Fire Chief Michael Moore, 3 members from Christie Walthers Communications Limited and 3 members from Westmeath Township Council arrived at the Council Chambers to discuss towers required for 911 communications, It was decided that the Protection to Persons and Property Committee of Amalgamating Municipalites is meeting on Tuesday, March 16th and it would be decided then when to have the tower installed. It will take 3 weeks after the order is placed to have it installed. Everyone left at 9:00 p.m.

Fire Chief Moore returned and asked Council for a raise in pay for firefighters.

Moved by Grant Somerville and seconded by Jacob DeWal that the Council of the Corporation of the Village of Beachburg hereby set the rate of pay for firefighters at the rate of \$14.00 per hour for the calendar year 1999. Carried.

The Millenium Committee was discussed with Michael who has been instrumental in forming a Committee and it was decided that Councillor Labow would be the representative from Council and that he would try to co-ordinate all of the interested Committees.

The Clerk had received a letter from Mrs. Elinor McLaughlin stating that she is thinking of building a house on her lot on the unopened road allowance on King Street and what her responsiblities would be. The clerk is advised to let her know that the Road and Waterline is her responsibility.

Notice from Ja.Ar Farms of Beachburg that they had cleared the snow from Fire Hydrants, free of charge, after the Snowstorm on March 5, 1999.
